



PRAVILNIK ZA KORIŠTENJE TOBOGANA – VAŽNO

- Tobogan mogu koristiti djeca od 4 godine starosti i odrasle osobe **težine do 80 kg.**
- Ispravan način ulaza/spuštanja niz tobogan je isključivo nogama naprijed, ruku pruženih uz tijelo.
- Sigurno korištenje tobogana – spuštanje se izvodi tako da korisnici idu jedan po jedan, s tim da sljedeći korisnik može krenuti tek kada prethodni izađe iz tobogana.
- Nije dozvoljen ulaz u tobogan i spuštanje za više korisnika istovremeno.
- Pri završetku spuštanja korisnik mora odmah izaći iz tobogana i oslobođiti prostor za sljedećeg korisnika.
- **Zabranjeno je ulaziti u tobogan s donje strane kao i penjanje uz tobogan.**
- Tobogan je konstruiran i postavljen sukladno važećim standardima i normama te certificiran sukladno propisanoj EN normi. Zbog sigurnosti korisnika, nužno je pridržavati se navedenih uputa.
- Roditelj, zakonski zastupnik ili osoba odgovorna za dijete dozvoljava svojoj djeci upotrebu tobogana na vlastitu odgovornost i mora biti prisutna uz dijete za vrijeme korištenja tobogana. Uprava Centra ne odgovara za bilo kakav oblik štete, ozljede i povrede uzrokovane nesigurnom, nepravilnom i nesmotrenom upotrebom tobogana.
- Zabranjeno je unošenje torbi, hrane, pića, životinja ili bilo kojeg drugog predmeta u tobogan.



RULES FOR THE USE OF THE SLIDE – IMPORTANT

- The slide can be used by children of at least 4 years of age and adults **weighing up to 80 kg.**
- The only correct way of getting on the slide and descending is with feet first and arms along the body.
- Use the slide safely – the users should go one by one so that one cannot start descending before the other one has finished.
- It is forbidden for more users to use the slide at the same time.
- After descending the slide, a user must step aside immediately to free the space for the following user.
- **Entering the bottom end of the slide and climbing up the slide is strictly forbidden.**
- The slide is constructed and installed in accordance with applicable standards and regulations and is certified in compliance with the prescribed EN norm. For the safety of all users, it is necessary to comply with the above instructions.
- A parent, legal guardian or person responsible for the child lets their children use the slide at their own risk and must be present with the child during the use of the slide. The Management of the Center is not liable for any form of damage or injury caused by unsafe, improper or reckless use of the slide.
- It is forbidden to use the slide with bags, food, drinks, animals or any other object.
