



## ***TERMS OF SERVICE - JUNGLE CLUB CARD***

Become a member of the Kid's Jungle playrooms Loyalty Club and benefit from a whole range of advantages: get a card that enables you to make your purchases with discounts from more than 30 partners in three shopping centres: City Center one Zagreb East, Zagreb West and Split, and you will always receive the latest news and event announcement for your kids!

You can ask for an application form at the reception desk of Kid's Jungle playrooms if your child already uses our playrooms.

Jungle Club Card is owned by Veseli kutak d.o.o., Jankomir 33, Zagreb, and shall be provided for use to any person over the age of 18 residing in the Republic of Croatia who applies by filling out an application form at Kid's Jungle playrooms in City Center one East, West or Split.

Each user may apply once at any of the locations of the Kid's Jungle playrooms. Subsequent application at another or at the same location shall not be accepted.

Each Jungle Club member shall receive our Loyalty Card to their home address and it will be valid indefinitely or until cancellation. In case your card is lost, please call 01/555-6960.

The card may only be used by the cardholder and it is not transferrable. Should the information from the application form change, the cardholder shall duly notify the issuer at any of the Kid's Jungle playrooms.

By signing the application form for the Jungle Club Card, the user agrees to the Terms of Service.

By applying and signing the application form for the Jungle Club, a person becomes a member of Jungle Loyalty Club based on which they can benefit from a wide range of advantages at City Center one, Kids's Jungle playrooms and with our partners at City Center one who are a part of the Loyalty Club project at the moment of application.

All discounts and special offers will be published on the Kid's Jungle and City Center one websites.

On the application form, users can give their consent about receiving newsletters through e-mail regarding discounts, events and different announcements and updates from Kid's Jungle playrooms at City Center one Zagreb East and Split.

Jungle Club discounts and special offers may not be combined with other special offers, discounts, promotions, coupons and club offers at different stores.

The special offer regarding the free 4<sup>th</sup> ticket in Cineplexx cinemas at City Center one Zagreb East and Split refers to the purchase of the 4<sup>th</sup> lowest-priced ticket in a single purchase.

The special offer regarding the free 4<sup>th</sup> ticket in Cineplexx cinemas at City Center one Zagreb East and Split does not apply to the online ticket purchase.

The special offer regarding the free small popcorn can be use up to 6 times in one day, meaning that one Jungle Club Card entitles the user to benefit from a maximum of 6 free small popcorn packs in a single day.

Jungle Club cardholders can obtain coffee at a reduced price once per visit in café bar Leggiero.

Jungle Club cardholders can use special benefit (surprise gift) at Kehl's only for one purchase a day, meaning, this benefit can not be used for more than one purchase per day

Presenting the card is mandatory while ordering the service and prior to the purchase of a product, in order for the discount to be applied on items and services which are currently a part of the special offer for Jungle card users, when the receipt is issued.

Kid's Jungle playroom and City Center one shall not be liable for possible cancellations or amendments to the terms and conditions regarding the products or services included in the special offer through Jungle Club at City Center one's partners.

### **Data Protection**

Your personal data provided on the application form by the card issuer (Veseli kutak d.o.o., Jankomir 33, Zagreb), as a data processing representative, may be used only for the purposes of issuing, sending and using the Jungle Club Card. Your e-mail address may be used for sending newsletters, only if the user has given a consent to this option, and while such a consent exists.
